

POAATAD is a Power Of Attorney to enable ResearchCity as led by **Laurence Loewe of Laodicea\LLoL** as attorney in-fact: POAATAD authorizes work for 1 year and is limited to gentle kind reasonably Advocating To Avert Disasters of any kind. ResearchCity aims to gentle kind reasonably avert worst disasters first by balancing diverse and dynamic requirements. ResearchCity builds on its best available work by refining **wide interdisciplinary diversity-encouraging \wid-e** research. To stay gentle kind reasonable, ResearchCity keeps improving by following the life-trifecta hallmarks of any epiocracy: epiocracy is defined by the trifecta-rule of gentle kind reasonable balancing. It implies the easing and explaining of parity-preserving insight-information for every party, integrating the views of each party (to cut bias by aggregating).

Under the epiocracy rules of gentle kind reasonableness, in this POAATAD power of attorney in-fact **I herewith empower Loewe and whom Loewe empowers through ResearchCity in order to ...**

- (1) ... **advocate** anywhere on my behalf to avert avoidable disasters, starting with the worst;
- (2) ... **scale up** gentle kind reasonably a sufficiently large ResearchCity, evolving in 7-8 stages (each ~1+6+1 month long) in order to effectively and efficiently avert nuclear winter by dismantling 7DUIs;
- (3) ... **solve** existential disaster challenges from local to global scales, by supporting free access to solutions from the insight-**Tree of Life-giving decision-support \ToL**, and by supporting ToL growth;
- (4) ... **negotiate** with Earth's "**10 Nuclear Kings**", the UN Security Council, and all relevant experts to "Put Earth in an Escrow" to avert nuclear winter until ResearchCity gets a chance to work;
- (5) ... **engage** with challenging cultural, social, political, economic, ... and spiritual questions or preferences to aid communication across old barriers to improve global healing resilience;
- (6) ... **start** building **AIPTO** into the global **Atlantic Indian Pacific Treaty Organization** that will assume responsibility for balancing *all* global security requirements – via advanced soft-war Work-Logic Cascades that no longer need nuclear weapons nor their brutal hard-war WoLCs;
- (7) ... **explore potential offers by extra-terrestrials** to aid humanity survive its Great Filter by helping to fight coveting mind-viruses; this includes especially **Jesus\Isa\YhowShua\Yas**, who also is an oppressed refugee academic from the Middle-East, hoping to lead a Jubilee-based self-stabilizing innovation economy before humanity self-destructs; because Yas defined and passed the hardest trifecta-vetting imaginable for extra-terrestrials, I expect Loewe to submit ResearchCity to Yas' leadership in any form Yas\RealQuestAnswer may return.

**As I execute this POAATAD transaction**, each unit of **~\$8/year/person/stadion** I transfer goes via Loewe and Loewe's subsidiaries to a 'mustard-seed network of trust'. It builds, guards, and runs ResearchCity to shield the world from accidental Armageddon disasters – by averting 'datageddon' confusion from misaligned data that triggers respective disasters if not resolved.

**I trust Reality in Real Quests for Real Answers to guide Loewe and thereby ResearchCity towards the most gentle kind reasonable solution accessible in any given context.**

Thus, I understand that Loewe must resist Blindly Authorizing and Auto-Stereotyping Habits to avert Mistakes Oppressing Life Qmitting Crucial Help, even if it can be hard to avoid common oversimplifications. I understand Loewe can only win through the scientific method of Jesus (to love all enemies by listening to all grains of truth they share). I understand that Loewe is not my enemy, even if Loewe talks to my traditional adversaries in open searches for global solutions. Loewe is bound to make mistakes. Hence, I support Loewe in documenting them as best as possible in his **Peer Evaluation Analysis Reviews Library**, to be shared in ResearchCity's global **Historically Experienced Lessons Library \HELL** as a public PEARL to reduce related mistakes.

**I understand:** (a) **All this is and stays voluntary.** (b) **I can afford to risk trusting Loewe for 1 year.** (c) **If I follow advice, I still carry all risks of (not) signing.** (d) **No refunds: I enable Loewe for 1 year.**

**Nuclear roulette** only ends if *all* work together to solve the worst existential "super-wicked" problems. These self-organize conflicts so evil, nukes seem desirable. - So-called '**Armageddon**' thus technically is "flooding by any of too many 7DUI-disasters to avert them by traditional means without globally growing a **7Capstone in Uniting States**". To survive, a '**7Cap**' must be the highest law in a global epiocracy constitution, where Reality's life-trifecta governs to:
- (1) form a more perfect union;
  - (2) improve general justice;
  - (3) grow domestic peace;
  - (4) provide common defenses;
  - (5) promote general welfare;
  - (6) secure all blessings of liberty;
  - (7) preserve posterity for all by waging peace in ResearchCity to support all **Fiduciaries Sharing Futures \FiShFus**.

# Limited Durable 1-year **Power Of Attorney Advocating To Avert Disasters** \ POAATAD

Contract with **Laurence Loewe of Laodicea \ LLoL** to win trust for his ResearchCity vision to avert Armageddon-disasters

Powers of attorney are sharp tools for guarding justice. Abuse is harshly punished. POAs are not given to someone not trusted.

Why then trust Loewe with a POAATAD when he's next to a completely unknown stranger? **Considering the alternatives shows why:**

**First**, it's a very limited POA that does not keep anyone from anything, including blowing up the world. It is biased against all who would like to blow up the world, because it empowers Loewe to advocate against destructive actions. Anyone can do that, but with this POAATAD Loewe no longer only speaks for himself. It also binds himself to see all sides when he uses his voice and insights to advocate against destruction by identifying certain actions as more likely to leading to disaster than others. Anyone who tried knows that this is complicated. Hence Loewe's need to also empower a ResearchCity for binding him to the Truth about Reality. **Loewe will only succeed if he stays in ResearchCity's light of full transparency. It's the only way to avoid growing nefarious secrets.** If Loewe isn't transparent enough, next year's

conceptual art PDF sale will cut his funding because (i) people will no longer buy into what he does, (ii) **sales must stay voluntary to work**, and (iii) **Loewe can't accept special-interest money if indeed ResearchCity is to work for all**

**Second**, all who default to "no" may wish to ask: (i) **"Do I have someone more qualified to advocate on my behalf to avert disasters?"** If so, wonderful. Loewe doesn't aim to interfere with anyone's good work. Like a dog under the table, he's only looking for crumbs ignored by others, because he found these suffice to destroy the world. His analyses of nuclear roulette and 7DUIs prove this point. (ii) **"What would be lost if Loewe got a chance?"** (iii) **"Given nuclear roulette, how can I prove Loewe's message is safe to ignore?"**

## 1. Offer +

**Loewe offers** his home, life, and all **to serve Reality** through **Real Quests for Real Answers** with all his aims, life, soul, future, intellect, strengths, links,... & all resources. To *gentle kind reasonably* resolve conflicts in serving all, Loewe offers **to build ResearchCity** from ~2-cent/day/person contributions as defined in Considerations below to efficiently scale shared ownership. To avert *over-simplifying overcomplicating overreach*, **Loewe's life will be transformed into an open book to lead the transparency** revolution in ResearchCity. In this **POAATAD you:** (a) Authorize Loewe to ask Yah\Reality to **forgive all your sins**; this is neither to forget them nor to stop learning from them but to end unproductive feelings of guilt etc. that else get in the way of learning. (b) Authorize Loewe to ask any Pharaoh to: **Let my people go** to wage peace in ResearchCity as led by the 288,000 **FiShFu \ Fiduciaries Sharing Futures** who follow Reality above all else, organized in **1600 Talent STadia**, each with a unique arena to serve the needs of all in its topical areas. The stadia are funded by Loewe's 2cent/day mustard seed network of trust (inspired by Yas' prophetic parables...). If a stadion doesn't deserve your support, don't buy into its conceptual art for next year. (c) Authorize Loewe to **hire FiShFus & other workers** as required.

## 2. Negotiation via *Evolving Diverse streams Encouraging Negotiation* +

(a) A ca. **42-day inquisition** by all **to explore** Loewe's offer, **to share** expert insights, **to debate**, and **to improve** Loewe's offer to better balance all. Loewe will openly follow Truth best Loewe can to improve words in this contract as the current wording requires more work to become truly *gentle kind reasonable* for all. Stage 1 in 8 starts if/when people & Yah fund enough for Loewe to start. (b) **Funding stays voluntary** at ~\$8/year/person/arena **max to cap special interests**. Suggested buy-in for all is Stadion 0 to avert nuclear etc. annihilation by leading ResearchCity with all other **1600 Talent STadia**, each with a specialized arena. Each of these 1600 arenas will rise or fall with annual ~\$8/year contributions it gets unless other arenas require its services to build on them (e.g. to meet needs for shared storage infrastructures). Thus, observed annual buy-ins from public sales are non-binding hints on which *wid-e* research is widely seen as most useful in public. They will be taken serious as recommendations because the highest responsibility of ResearchCity is to serve all people. But as looks can be deceptive, public requests are only followed if not overruled by more crucial functional requirements (e.g. to fund stadia that serve all other stadia by storing their data). Hence, public choices matter, but there is no right to demand any particular implementation. (c) **YasPyrApp feedback** flow. Starting with the [YasPyr.com](https://YasPyr.com) website, an app and a Living Docs format is envisioned to aid *gentle kind reasonable* negotiating by better integrating insights.

(d) **Loewe evolves Limited Liability Charitable Company** rules for max transparency: giving away 50% as <sup>a</sup> tax, <sup>b</sup> to investigative journalists, and <sup>c</sup> to the most life-giving hero work in urgent need – as seen by Loewe or delegates with the aid of feedback by all as best as everyone can.

## 3. Consideration = Contract defined

(a) **Bootstrap sale.** Loewe is late by ~7 years. To not punish all by overly limiting Loewe's startup funding, a "retro-sale" is organized for the last 7 years and allowing those with a credit card to buy art for up to 7 people without a credit card. Thus, the recommend **max** of ~\$8/person/year/arena remains unchanged, but those who want can support up to 7 other people without credit cards for up to 7 years into the past, up to \$400 **max**. (b) **All sales are final.** They pay for the conceptual art PDF received 'as-is' in its current state-of-its-art of integration. **No refunds.** No guarantee that future semantic improvements will not change meaning as Loewe aims to make contracts more *gentle kind reasonable* for all futures. Don't buy if you don't want to risk **trusting Loewe for 1 year as attorney in-fact to advocate for averting any all disaster best he can.** If you have better attorneys for averting a nuclear etc. Armageddon, signing this POAATAD encourages you to work with them too. They might avert what Loewe can't. This draft POAATAD is not yet in perfect legal language, so you support Loewe's efforts to make it more gentle kind reasonable. Here are the benefits for all parties:

(c) **Loewe gets to lead his Evolvix research** on *ambiguous semantics of nothing \ ason* by improving his universal **Staybilizing Versioning System \ StayVS** for all 1600 ST of ResearchCity in order to lead the global war against misinformation.

(d) **Everyone benefits** from StayVS' power to cut confusion that is else bound to destroy the world in pointless disasters.

**5. Risks of not signing:** Without a better counteroffer, conscious rejection may advance humanity's self-destruction. But if one can guarantee the world is safe because "*nothing* is wrong", "*nothing* goes wrong", & "*nothing* can go wrong", no risks exist.

## 4. Risks of signing

Risk in life is unavoidable. Here is Loewe's analysis of risks in signing POAATAD:

**a. Financially.** Limited to no refunds. The \$8 limit/year/arena is designed to ensure this huge operation does not impose big risks on anyone but Loewe.

**b. Socially.** If Loewe is presented with an over-night unicorn from this sale, and if Loewe – despite all his planning for how not to bow to money – still loses his plot, then Yet Another Billionaire was created. Many of those exist already, so the world stays the same. Another hope is trashed.

**c. Politically.** Culture wars are always against some "devil" and people are said to prefer "the devil they know" over "a devil unknown". Which deal then is not a Faustian bargain with a devil?

Loewe hopes to change this by following Yah & Yas and by funding ResearchCity to get it right.
